INDICATION AND PURPOSE

Paper points are used to dry the root canal before obturation and to clean the root canals that are to be sealed in endodontic treatments.

INSTRUCTION FOR USE

1. Measure the length of root canal
2. The formation of the root canal of the same size as the last file to select
3. The root canal using paper points to dry
4. About 10 ~ 15 points is used per a root canal
5. Sealer or cement is applied by using paper points

CAUTIONS

1. Should be use sterilized paper points
2. Do not use bent or broken points
3. Should be careful to avoid overfilling or dead space when applied sealer or cement
4. Use it immediately when applied sealer or cement
5. After using the paper points, should be kept in a cool place
6. Do not expose to direct sunlight
7. Do not reuse to prevent cross infections.
 (Secondary infections such as pathogens and viruses caused by saliva and blood)

STORAGE

Store at room temperature of 1°C~30°C(33°F~86°F)
